### PAYMENT REMINDER

- **BVI** first period companies that did not meet their July annual license fee plus 10% surcharge payment will incur an additional 40% penalty starting August 1.
- **Panama** first period companies that do not meet their license fee payment by July 15<sup>th</sup> will incur an additional US\$ 50 penalty fee.
- **Belize** companies that do not pay their annual license fee before July 31<sup>st</sup> will incur an additional 10% penalty starting August 1st.

During the month of July, OMC made a donation to Parque Natural Metropolitano for one of their reforestation projects of one seedling for each one of our OMC employees plus 55 seedlings representing our years of service.

The Parque Natural Metropolitano has 232 hectares plus 1,159.43m2. This protected area is one of the last spots of the almost extinct pacific dry forest in Central America.
